LAW No. 43 of 28 October, 1974.

THE PRESIDENT OF THE SUPREME REVOLUTIONARY COUNCIL

TAKING NOTE of the approval of the Supreme Revolutionary Council and the Council of State Secretaries;

PROMULGATES

the following Law:

Article One

1. The Credit Agreement signed between the Government of the Somali Democratic and the Arab Fund for Economic and Social Development is Hereby Ratified.

2. The Amount of the Credit is US Dollars Seven Million and Threehundred Thousand (7.300.000).

Article Two

1. The Credit Agreement shall have the Force of Law in the Territory of the Somali Democratic Republic.

2. This Law of Ratification shall come into Force immediately and shall be Published in the Official Bulletin.
