II. TARJU MAD/MICNAYN.

1 Dal Daddhis Xarafkaan, markii Af-Soomaaliga loo eego, Dastuurkaan dhexdiisa micnaha uu ku leeyahay waxa weeye: Land & human Resources Development (LHRD).

III. UJEEDDADA HAY'ADDA LOO ASAASAY.

Hay'addaan Dal,Daddhis waxa loo Asaasay in ay gacan ka geysato baahjda beeraleyda yaryar si ay u siyaadshaan waxsoosaar,kooda dhanka cuntada isku filaanshahoodana kor ugu qaadaan.

IV. HAY'ADDA XARUNTEEDA.

Hay'adda Xarunteedu waxay ku ooleysaa Xamar, hase ahaatee, haddii loo baahdo ama ay ballaarato hay'adda sha qadeedu, waxa laamo laga furi karaa meejihi ku habboon oo waddan ka gudihiiisa, khaas ahaan nawaaxiga beeraha.

V. UJEEDDOOYINKA HAWLEED.

Sugitaanka iskuffillaant dhanka cuntada iyo waxsoosaarku waa waajibka ugu horreeya oo ummad kasta saawan, arrin taas oo ah baahi Soomaaliyahadda ka taagan aadna uuga fog dhammaystir. Hay'addaan Dal,Daddhis waxay si weyn isugu taxalujimaysa iyadoo la kaashanaysa hay'adda kolo oo samafalkaa (kuwa gudaha iyo kuwa djbeddaba) inay ga can ka geysato horumarinta beeraha. Hay'addu waxay si khaas ah isugu taxalujinaysa horumarinta beeraleyda yaryar, tacliinta beeraha ee beeraleyda yaryar iyo horumarinta mashruucyada yaryar.

Dal daddhis waxa ujeeddooyinkeeda laf dhabar u ah

inay door weyn ka gasho wax ka qabashada cunta yarida taasoo ku dhisan qorsha dheer. Daqaddhis waxay ahaanay sa hay'ad aan siyaasi iyo faa'iido doon midna ahayn (NGO, waxay fulinaysa ujeeddooyinka halkaan ku qeexan.

VI. Ujeedooyinka iyo sharciyada kale oo hay'adda

1. Inay hay'addu wax la qabsato oo isla jir ula shaqayso hay'adaha kale oo samafalkan kuwa gudaha iyo kuwa dibed-daba.

2. Inay hay'addu ku darman karto hay'ad kale oo samafal ah, wixii lihi ah oo hay'adda wax ugu yaalna ay ka qaadan kartu, haddii waxaasi wax Dal_dad_dhis ujeeddooyinka keeda waafaqsan yihiin bulshadana wax ugu yaal.

3. Inay hay'addu fuliso ujeedooyinkeeda iyadoo ku tala geleysa mas'uulyadda u qaadysa, intii karitaankeeda, kharajka maamulka hay'adda.

4. Inay hay'addu dhanka maaliyadda kala xiriiri karto waxna ka raadsan karto hay'adaha ama shaqsiyaalka gacan ziilya samafalka, iyadoo si sharciga waafaqsan danina ugu jirto bulshada faa'iido raadsina aysan ku jirin arrintaas u meel marinaysa.

5. Hay'addu waxay xaq u leedahay inay ama aqbasho ama diido wixii cawimaad ah oo cid kale u soo gudbiso.

6. Hay'addu waxay xisaab ka furan kartaa hadday maa-mulka hay'adda ula muuqato lagama maarmaan Bankigii ay doonto.

VII. Guddiga Maamulka Hay'adda

Guddiga maamulka hay'dda wuxuu ka koobnaanaya xubnaha hoos ku tilmaaman:-

1. Guddoomiye

2. Maareeye

3. Mareeye ku xigeen

4. Xisaabiye

5. Xoghaye

Waxa dhici karta haddii ay maamulka hay'adda la habboonaato inaan mararka qaarkood jagoooyinkaas kor lagu soo sneegay lagu isticmaalin qaarkood. Guuduga maamulka hay'adda turadoodu kama yaraan karto sadaex (3) xubnood kamaana badnaan karto toddoba (7), taasoo ku xiran go'aanka asaasayaasha maamulka, shaqada iyo wixii hay'addu leeda-hay oo dhan waxa maamuluya guudiga maamulka hay'adda. Si hay'adda shaqaadeeqa iyo ujeedooymkeeda lagu fuliyo guddiga maamulka hay'addu wuxuu awood u reeyanay muu qorto snaqaale u qalma snaqada, waxaana lagu xaq marina-yaa shaqaalahaa siin tagula heshiyo. Haddii ay ogadaan asaasayaasna hay'addu in snaqsi snaqaalahaa hay'adda ka mid ahi ku kaco waxyaabo ka soo horjeeqa danana iyo ujeeddooyinka hay'adda, asaasayaashu arrintaas waa inay ka qaadaan xiliga ku habboon waqtii xadadan.

Mas'uuliyaha Guudiga Maamulka Hay'adda

1. Guudoomiyeye

Guddoomiyahana mas'uuliyaddiisa waa inuu fadhiyada ama shirarka guddiga maamulka socodsiiyo haddaan wax ahi ka hor istaagin.

Guddoomiyuhu wuxuu qatanayaa wixii caadi ahaan shaqo guddoomiyeye ah.

2. Maareeyaha

Maareeyaha shaqadiisu waa inuu mas'uul ka yahay hawlahaa fulinta hay'adda dhan kastaabha ha ahaatee, waana inuu shaqada guddoomiyaha qabtaa markii guddoomiyuhu maqan yahay.

3. Maareeye ku xigeenka

Shaqadiisu waxa weeye inuu la shaqeeyo maareeyaha, haddii maareeyaha iyo guddoomiyuhu maqan yihiin shaqadooda fuliyo.

4. Xisaabiyyaha

Iyadoo ku xiran hadba sidii maamulka go'aansho xisaa-biyuhu wuxuu mas'uul ka yahay arrimaha lacag qabashada iyo lacag bixinta ee hay'adda, isagoo muujinaya risityada iyo fowjariska arrimahaas la xiriira. Guud ahaan xisaabiyyuhu waa inuu hayaa oo kaydiyaa hay'adda xisaabaadkeeda, buug-teeda lacagta uuna diyaarsho xisaabaadka bishiiiba hal mar isagoo tusaya oitarada markii loo baahdo.

5. Xoghayaha

Qapashada shaqada guud ee xoghaynta ka sokow, xoghaynu wuxuu qaabsan yahay arrimana la xiriira qoraa-lada, diyaarinta fadhiyada guddiga maamulka, haynta iyo kaydinta go'aammada Guddiga.

VIII. Shirarka Guddiga Maamulka Hay'adda.

Guddiga Maamulka Hay'addu ugu yaraan bishiiba hal mar bay shir yeelanayaan, shirkana waxa madax ka ah guddoomiyaha, markuu maqan yahayna, Maareeyaha ama hadday labaduba maqan yihiin, maareeye ku xigeenka, Mar-kii shir la leeyahayba ugu yaraan boqolkiiba konton waa inay guddiga maamulka ka joogtaa.

N.B. Hay'adda Guddigeeda Maamulka sannadkiiba hal mar ayaa hawlhiisa dib muraajaco lagu samaynayaa, haddii maamulka badidiisu isla gartana mas'uuliyadaha waa la kala beddeli karaa. Qofkii ka maqnaada saddex jeer oo isku xigta fadhiga guddiga, guddiga intiisa kale ayaa go'aan ka gaareysa arrintiisa.

IX. Guddiga la Talinta

Guddiga la talintu wuxuu ka kooban yahay afar qof oo mid walba takhasus beeraha ama maamulka leeyahay. Guddigu wuxuu leeyahay khibrad xagga beeraha iyo maamulkaba.

X. Taageerada hay'adda (u fidinta taageerada hay'adda)

Qofkii ama hay'addii doontaa waa taageeri kartaa hay'-adda, iyadoon loo eegin dhan diin, waddan, dhalasho iyo wax kale midna, hadday arrintaasi waafaqsan tahay sharciga iyo ujeeddooyinka hay'adda Dal-daddhis. Ciddii taa-geero bixisaa dib uma ceshan karto wax khaas ahna ma tir-san karto oo hay'ada xaggeeda.

XI. Asaasayaasha

Asaasayaasha oo xubno ka noqon kara guddiga la talinta iyo kan Maamulka labadaba, waxay ahaanaysaa kuwa leh go'aanka kama dambaysta ee wax alla wixii la xiriira arrimaha hay'adda. Wixii ka hor imaanaya danaha iyo ujeeddooyinka hay'adda waa joojin karaan, Asaasayaashu waa agaasin joogtaa ee hay'adda ilaa ay ka geeriyyodaan.

XII. Fałashka Xisaabaha (Auditing)

Sannadkiiba mar waxa guddiga maamulka hay'addu xil saarayaa hal ama labo qof oo tatasha xisaabaadka hay'-adda. Fataashayaashu waa inaysan ka tirsanayn maamulka hay'adda. Xisaabiyaha hay'addu wuxuu u oggolaanayaa fataashka xisaabaha wixii dokumenti ah oo xisaapaad la xiriira. Fataashka xisaabuhu wuxuu maamulka iyo taageerayaasha u xisaaynayaa khaladka ama saxnaanta xisaabaadka hay'-adda.

XIII. Wax ka beddelidda Dastuurka hay'adda

Dastuurka hay'adda waxa wax laga beddeli karaa had-dii ay oggolaadaan guddiga maamulka hay'addu intiisa bandan iyo asaasayaasha hay'adda, waxaase go'aanka kama dambaystaa leh asaasayaasha.

XIV. Baabi'inta ama xiridda hay'adda

Haddii guddiga maamulka hay'adda iyo asaasayaashu, iyaga oo tala weydiisnaya guddiga la talinta, ay gartaan inay quman tahay in hay'adda la baabi'iyo oo la xiro, ama ay u gartaan in aysan raa'iido u lahay sii wadiddeedu hay'-adda waa la xiri karaa. Hay'adda baabi'inceedu waxay ku xirnaanaysaa go'aanka kama dambaystaa ee asaasayaasha. Haddii hay'adda la baabi'iyo, hay'adda hantideeda markii laga jaro wixii hay'adda lagu leeyahay, wixii soo hara waxa la siin karaa hay'ad kale oo samafal ah, ama waxa loo maamulayaa sidii ay asaasayaashu ugu taliyaan ama ay ula habboonaato.

CONSTITUTION

I. Name:

The organization will be known as Dal_Daddhis, herein after referred to as Land & human Resources Development.

II. Interpretation:

1. Dal_daddhis: This word, in S_omali language, means Land and human Resources Development.

III. Statement of Purpose:

Dal_daddhis is established to improve the quality of life in rural Somalia by meeting basic needs and helping increase self-reliance in food production.

IV. Main office:

The head office of Dal_Daddhis will be situated in Mo-gadishu, Somalia. In case of need and/or expansion of the services of Dal_daddhis, branch offices could be opened to other appropriate centers in the countryc.

V. Service objectives:

The food security of the nation is much more important than any other security need, and S_omalia is faced with the task of feeding its people. This need is far from being met and, Dal_Daddhis will strive, with the help of other national and international NGO's, to further agricultural development. The organization will especially engage in agricultural development and education of small-scale farmers and small income generating community development on humanitarian basis. Dal_Daddhis central objective shall be assume a major role in solving food shortages among communities on long range basis.

Dal_Daddhis sahll strictly remain and operate as a non-profit indigenous NGO and non-political organization. In furtherance of the objectives, but not further or otherwise, Dal_Daddhis shall exercise the implementation and/or participation of the following principal services.

1. To assist farmers in the legal aspects of land procurement.

2. To provide technical assistance to farmers (esp. small-scale farmers).

3. To assist in irrigation needs (canals ect.)

4. To help provide water (hand-dug/drilling of water wells for farmers).

5. Production (from animal bones) and procurement of fertilizers.

6. Provision of seeds.

7. Pest control (procurement of pesticides).

8. Supply of small-scale farm implements.

9. Agricultural education.

10. Nurseries (for planting fruit trees).

11. Creation of small income-generating projects for communities.

12. Emergence/disaster participation (floods, food shortages etc).

13. Production of Solar stoves (for rural communities).

14. Production of cheese, butter and ghee.

15. Animal husbandry.

16. Aluminium recycling.

17. Vegetables drying.

18. Any other charitable projects within the reference of the aims and objectives of the organization as deemed appropriate by the management.

19. Elimination of illiteracy through greater self-help with participation and support of the government.

20. Encouragement of vocational education emphasizing work experience training with involvement of business & Industry.

21. Expanding opportunities for higher education up to University level through international assistance as a grant scholarship.

22. Organizing of buildings with community and self-help schemes.

23. Procuring cultural material like tex-books, stationary etc, from in and abroad.

24. Organizing school system in districts where higher proportion of disadvantaged children are located.

25. Increasing incentives for seeking employment & job training.

26. Providing food & other necessary assistance for those who are unable to care for themselves.

VI. Other objectives/policies.

1. To collaborate & cooperate as considered appropriate with national and international non-governmental and governmental organizations.
2. To merge or affiliate with, acquire and/or take over any charitable organization and all or any assets in furtherance of Dal_daddhis objectives.
3. To carry into effect the objectives of Dal_daddhis, by making proper arrangements and for this purpose provide expenditures to the management of the organization.
4. To raise funds primarily from funding organization and individual donors as shall be considered appropriate, legal and expedient without undertaking any transaction where profit-seeking is involved; and reserve the right to accept or decline any donation or assistance without prejudice to the generality of Dad_daddhis.
5. To open and maintain a banking account or accounts in the name of Dal_daddhis at any bank and at any time as may be deemed necessary; and to do all such other legally permissible activities in furtherance of the organization's objectives.

VII. The Executive Board

The Executive Board of Dal_daddhis shall consist of the following officers:-

1. Chairman
2. Executive Director
3. Vice_Director
4. Treasure
5. Secretary

Some of the executive Board offices may not be utilized at times if so deemed appropriate by the management. The Executive Board shall maintain a minimum of three (3) and a maximum of seven (7) members, depending on the final judgement of the Founders. All the administration, business, property and finances of Dal_daddhis shall be administered by the Executive Board. In order to carry out the normal operations of the organization, the executive Board shall have the power to recruit or employ any eligible individual as and when considered necessary, depending on the final

approval and decision of the Founders. The persons so employed shall be recompensed as agreed upon.

In the event it comes to the knowledge of the Founders that any employes of the organization has committed actions that contravene the interest and the objectives of the organization, the Founders shall draw the attention of whoever is involved to the matter and will take appropriate action within specified time period.

Responsibilities of the Executive Board

1. The Chairman

The chairman is to function as one of the principal leaders of the organization and will be responsible for the presiding over all meetings of the Executive Board, unless otherwise prevented by a force majeure or her reasonable cause.

2. Executive Director

The responsibility of the Executive Director is to function as one of the principal leaders of the organization and will be responsible for the execution of the organization's managerial operations.

3. The Vice-executive director

The function of the Vice-Director is to closely work with the Director and the chairman and perform their duties when both are absent.

4. The Treasurer/accountant

Based on the decisions and directions of the management, the treasurer will perform the duties of receiving and disbursing of organization funds and should issue receipts for moneys received and maintain vouchers for disbursements. As a whole, the treasurer will be responsible for the organization in the matters of financial record-keeping, preparation of financial statements and preservation of account and books for auditing and/or inspection.

With the prior consultation and approval of the management, the treasurer could delegate part of his duties to another employee under his supervision and will be held responsible for the proper appropriation. All funds disbursed on behalf of the organization will be authorised by the Executive Board. The Executive Board will be responsible

for all the managerial duties of the organization and may give leadership and direction to the employees in a manner commensurate with the aims and objectives of the organization.

N.B. The responsibilities and the positions of the Executive Board are reviewable at any time considered appropriate by the majority of the Executive Board and the Founders.

5. The Secretary.

Under the directions of the management, the secretary, besides being responsible for the performance of all the normal secretariate duties of the organization, will carry out all the duties pertinent to the correspondence, preparations of schedules to convene meetings and keeping minutes and preservation of records of organization proceedings.

VIII. Executive Board meetings at least once a month, The Chairman; or in his absence the Executive Director or in the default of both these, the Ex-Vice-director will preside all meetings of the organization. The quorum for the executive board meetings will not be less than fifty percent.

Any member failing to attend three consecutive meetings of the Executive Board without some genuine cause, shculd receive a written notice for justification from the chairman. However, at the event that such a member fails to come up with justifiable reason or continues to be absent from meetings, the rest of the management will take action and he shall cease to be a member of the Executive Board. At his discretion, the chairman shall decide the number of persons allowed to speak against a motion or in favour of it, and resolutions will be made by a simple v_ote of raising hands.

IX. The Advisory Board

1. Two (2) degree holders in agriculture with lost of experience in farming.

2. An economist/accountant with sufficient experience.

3. An engineer/administrator with adequate experience.

The Advisor Board of the organization shall be registe-

red at the Notary Public of Mogadishu, The number of the Advisory Board shall be not less than three (3) persons at any one time.

X. Supporters/contributors

Any organization or person, regardless of country, Nationality, race, color and fatih shall be eligible for becoming a supporter, donor or a contributor of Dal-daddhis, such supportship being subject to the consent of the Executive Board.

The principal function of a supporter, contributor or a donor, is to assert his support to the organization both in word and action, but cannot claim any special rights or privileges. The executive board of the organization reserves the sole power and responsibility to sacton or reject any offer or application of supportership.

Supporters shall be expected to pay an amount of subscription individually as may be decided from time to time by the management of the organization. Any supporter desiring the resign from the organization's patronship, shall nave the right and privnege todo so; however, such resignation due consideration to the matter.

The execuuive board shall have the authority to discon-
tinue and/or exclude any supporer from his supportership
for a specified time period, on such grounds that he acts in
a manner inconsistent or detrimental to the policy and the
interest of the organization.

Any organization or person who gives up or expelled
from the status of being a supporer or contributor, will not
be entitled to any reimbursement of contributions or sus-
criptions or any part thereof or any value contributed by
him at any time.

The managenent of Dal-daddhis shall be vested with
the responsibility for all the properties, funds and invest-
ments acquired in the name of the organization. However,
to promote agricultural development in Somalia, Dal-daddhis
shall seek and endeavor to facilitate collaboration and coope-
ration with other indigenous and international NGOs, in par-
ticular, the organization shall work together with funding
organizations as equal partners in designing programmes and
development projects. Dal-daddhis will cooperate or colla-
borate with any organization and will make agreements with

them to obtain any aid, in the form of materials, funds, services and/or manpower in order to run its projects in compliance with the set organizational objectives.

XI. Founders

The founders, who function both in the Advisory Board and the Executive Board, shall be consulted in all decisions as the final authority in the decision making of the organization's affairs. They may overrule any decision if they have reason to believe that it is against the interests and the objectives of the organization. The founders shall remain as the supervisors of the organization for life (their names are appended to this constitution).

XII. Auditing

An auditor who is not an office holder of the organization, will be appointed by the Executive Board for every year to audit all the records, accounts and the books of the organization.

The treasurer or the accountant of the organization will produce all the necessary documents to be audited to the auditor and the auditor shall be expected to either certify the records as correct and vouched in accordance with organization's policies and proper accounting principles or state his opinion and findings to the contrary.

XIII. Amendments:

The constitution of the organization can be amended, if the amendment so proposed is approved by the majority of the Executive Board and the Founders.

XIV. Dissolution:

If the Executive Board, with prior consultation of the founders and the Advisory Board, decides unanimously that the object of this constitution cannot and will not continue to be carried out or at any time determines that it is advisable to discontinue the organization, the assets remaining after all debts & liabilities are satisfied, could be given to a charitable organization, or shall be supervised by the Founders in the best way appropriate.
