For the use of public Telex by none subscribers, administration shall charge in addition to the normal tariff rate, fees for services done on the following rate:

- (a) For first three minutes or part thereof, amount not exceeding 15% of the actual charge.
- (b) For each minute in excess of 1st 3 minutes, there shall be a charge at the following rates:

For Kenya, Tanzania and Uganda	Sh. So. 1,70
For 1st Group	Sh. So. 3,40
For 2nd Group	Sh. So. 4,50
For 3rd Group	Sh. So. 5,65

Article 2

This decree shall be published in the Official Bulletin and shall come into force with immediate effect.
