HEREBY PROMULGATES

The following Law:

Art. 1

The Agreement between the Government of the Somali Democratic Republic and the African Development Bank equipment and facilities for the repair and maintenance of the road Network in Somalia is hereby Ratified. The money required for this project is 3 three million Dollars with an interest rate at 3/4 of 1% a year.

Art. 2

The above mentioned Agreement shall have the force of law in the territory of the Republic and shall form Part of the Laws of this Republic.

Art. 3

This Law shall come into force immediately. It is signed by the President of the Supreme Revolutionary Council.
