INSTRUMENT OF RATIFICATION

HAVING SEEN: The 1st, and. 3rd Charters of October 21st, Revolution 1969.

HAVING SEEN: Law N. 1 17, 18 and 19 of 1st. July, 1976.

TAKING NOTE: Of the approval of the Political Bureau and that of the Council of Ministers on 20th January, 1977,

HEREBY PROMULGATES THE FOLLOWING LAW

ARTICLE 1

The Agreement on Immunities and Privileges for the Organisation of the Islamic Conference, adopted by the seventh Islamic Conference of Foreign Ministers, held in Istanbul, is hereby ratified.

Article 2

The Agreement shall have the force of law in the Territory of the Somali Democratic Republic in accordance with its articles 33 and 34.

The law shall be published in the Official Bulletin of the Somali Democratic Republic.
