

The following Decree:

Article 1

The Loan Agreement the Government of the Somali Democratic Republic and the African Development Fund (Central Rangelands Reserch and Development Project -phase II), signed in Abidjan on Ivory Cost, is hereby retified.

This Agreement shall have a force of Law in the Territory of Somali Democratic Republic.
