

THE PRESIDENT OF SOMALI DEMOCRATIC REPUBLIC

Having Seen: The 1st, and 3rd Charters of 21st. October Revolution of 1969:

Having Seen: Law No. 1,17,18 and 19 of 1st. July, 1976.

HAVING SEEN: The Loan Abreement between the Somali Democratic Republic and the Federal Republic of Germany, Signed at Frankfurt on 2nd. February, 1977.

TAKING NOTE: of the approval of the Political Bureau an the Council of Ministers on 7th April, 1977.

Hereby promulgate the Following Law:-

Article 1

The Loan Agreement between the Government of the Somali Democratic Republic and the Government of the Federal Republic of Germany, signed at Frankfurt on 2nd. February, 1977, is Hereby ratified.

Article 11

The Agreement shall have the Force of Law in the territory of the Somali Democratic Republic and shall be published in the Official bulletin of the Somali Democratic Republic.
