THE PRESIDENT

TAKING NOTE of the approval of Standing Committee of the People's Assembly;

HEREBY PROMULGATES

the following Law:

Article 1

It has been approved tariff reduction on commodities indicated in the annex of this Law within the Countries of Preferential Trade Area of Eastern and Southern African States (PTA) of which the Somali Democratic Republic is a full Member.

Article 2

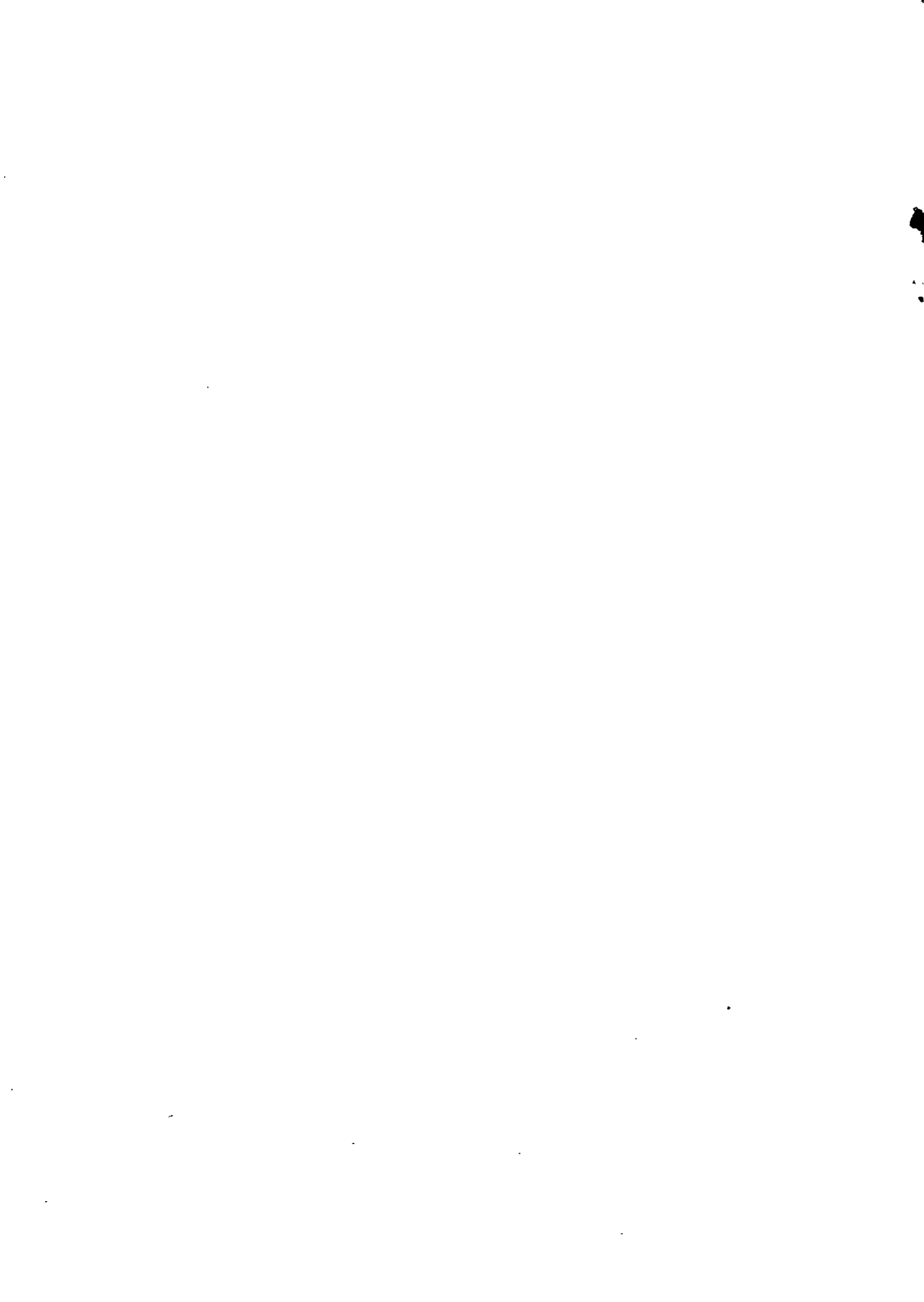
Commodities which cover the Tariff reduction should originate from the Member countries of the Preferential Trade Area in complicate with Protocols No. 1, 2 and 3 of the PTA Treaty which Somalia has implemented on the Law No. 21 of 20th, June, 1982.

Article 3

The above mentioned Tariff reduction will be effective on the date of the signature by the President of the Somali Democratic Republic and will be published in the Official Bulletin of the State.
