THE PRESIDENT

HAVING SEEN: the Article 67, para 5 and the Article 82, para 4 of the Constitution of the Somali Democratic Republic;

HAVING SEEN: the Law No. 49 of 23 December 1984;

HAVING SEEN: the Law No. — of 28 Sep. 1987 on the base of which the People's Assembly has approved the Agreement specified in this Decree;

HAVING CONSIDERED: the necessity to ratify this Agreement;

HEREBY PROMULGATES

the following Decree:

Article 1

The Development Credit Agreement (semi-mechanized Rainfed Agriculture Pilot Project) between Somali Democratic Republic and International Development Association, signed in the District of Columbia (USA) on April 13, 1987, is hereby ratified.

Article 2

This Agreement shall have a force of Law in the Territory of Somali Democratic Republic.

Article 3

This Decree shall come into upon signature by the President of Somali Democratic Republic and shall published in Official Bulletin of the State.
