#### Qodobka 1aad

Haddii markab shisheeye ahi soo galo dekedaha Soomaaliya iyadoo aanu wadan xaashiyaha sharciga ah ee loo baahan yahay, ama uu si sharci darro ah ugu xad gudbo badda Soomaaliyeed (Somali Territorial Waters), ama ku dhaqaaqo ama wax ka keenay asagoo qeyb ka gaatay waxyaabo dhaawici karkara danaha Siyaasadda, Dhaqaalaha ama danaha Guud ee Dowladda Soomaaliyeed si toosan ama si aan toosneyn (directly or indirectly) waxaa markaabkaas galay dembi.

#### Qodobka 2aad

1. Markab kasta oo shisheeye ah oo uu ku caddato inuu galay dembiyada uu dhigaayo sharcigan kuna saabsan:

i — soo gelidda dekedaha soomaaliyeed isagoo aanu wadan xaashiyaha sharciga ah ee loo baahan yahay; iyo

ii — ku xad gudub badda Soomaaliyeed (Somali Territorial Waters) wuxuu muteysanayaa ciqaab ganaax ah oo gaadhaysa Shs. 10.000 (tobonkunshilinsoomaali) ilaa Shs. 100.000 (boqol-kunshilinsoomaali). Bixin la'aanta ganaaxaa muddo soddon beri

i — **Ganaax gaaraya ilaa seddex jibaar qiimaha dhibaatada** «demege» markabka keenay ama wax ka keenay si toos ahaan ama toosneyn (directly or indirectly).

ii — Qabasho markabka (temporary sequestration) ilaa laga bixinaayo ganaaxa seddex jibaarka ahi;

iii — qaadasho markabka (confiscation).
