

Having seen: Article 22 of Law No. 18 of 14.8.1963;

Having seen: The Guarantee issued by the Central Bank Of Somalia, Mogadishu, covering the credit facility agreement between the Commercial And Savings Bank Of Somalia, Mogadishu, and Bank Of Kuwait and the Middle East, Kuwait;

Having deemed it necessary to authorise the Commercial and Savings Bank Of Somalia to obtain credit facilities from Bank Of Kuwait and Middle East, Kuwait.

DECREE THE FOLLOWING:-

ARTICLE I

1. The Commercial and Savings Bank Of Somalia, Somali Democratic Republic is hereby authorised to obtain credit facilities from Bank Of Kuwait And Middle East, of Kuwait and thereby enter into an agreement for the purpose of effecting the said credit facilities.

2. The Central Bank Of Somalia, Mogadishu, is also hereby authorised to issue Guarantee covering the credit facilities specified in para 1 above.
