PHD — GENERAL

Participating Home Development (phd) is an SPVD) with objectives which are non-religious, non-political and not for profit. It is non-governmental, and public service oriented, receiving revenue from the private sector, international agencies, and voluntary contributions of funds, staff time and in-kind contributions from the general public.

PHD's policy of development is based on the cultural adage, «contribute, then develop». PHD has been organized under Somali law, and initially will conduct operations in Somalia. After gaining experience, it is intended to expand operations to other developing countries.

PHD has established its own by-laws which outline its objectives, purposes and management procedures. Purposes and priorities are to be further defined, based on decisions of its Board of Directors.

Groups which will benefit from PHD activities include disabled persons refugees, rural poor, women and the elderly.

PHD — OBJECTIVES & PURPOSES

- 1) To mobilize voluntary action, cash and in-kind contributions from the private sector and communities.
- 2) To promote a self-help philosophy, development a strong sense of ownership and concern for continued operation and maintenance of facilities.
- 3) To generate employment for the unemployed poor.
- 4) To establish, a cadre of Somali development professionals, capable of understanding and implementing grass roots development.
- 5) To establish, support and develop the capacity of Somali NGO's enabling them to define their goals and priorities, influence community decisions, and implement and manage local development projects.
- 6) To establish and support new income generating mechanisms, and to develop existing mechanisms.
- 7) To improve the quality of life of the indigenous people and refugees in cities and rural areas.
- 8) To establish and support new enterprises, and to develop existing enterprises.
- 9) To encourage agricultural groups, assisting them with

market surveys, export arrangements and the like.

10) To upgrade the skills of indigenous workers and professionals, through on-the-job and other forms of training, both inside Somalia and abroad.

11) To promote international trade relations and international cooperation in the area of development.

12) To provide liaison and promote an exchange of information between local government and international donors, through the establishment and maintenance of a data base and information center.

13) To develop qualifications in management and accounting comparable to those of an international PVO, through cooperation with more experienced development first in joint ventures, subcontracts and the like.

14) To engage in development projects that fill a need which has been expressed by people, are highly visible, are participatory and whose benefits are equitably distributed.

15) To offer women and womens groups full opportunity to actively participate in all projects.

16) To expand the role of PVOs in assisting the Government of the Somali Democratic Republic in development throughout Somalia.

17) To work closely with local, district, regional and national authorities in planning and implementing development projects.

PH D— RULES OF BOARD OF DIRECTORS

1) The Board of Directors shall be composed of men or women, and shall include a Chairperson, Auditor and five regular members.

2) Members of the Board of Directors will be nominated by the founder of PHD after the organization is registered with the Somali Democratic Republic.

3) The Chairperson shall be elected by the members of the Board.

4) Regular meetings of the Board shall be held one time per year. Extraordinary meetings may be called by called by any member of the board at any time.

5) Decisions shall be made by majority vote of the Board, with each member having one vote. A quorum of at least four members must participate in each binding vote. In the

event of a tied vote, the Chairperson's vote shall prevail.

6) No member of the Board will receive monetary or other compensation for duty performed on the Board.

7) Minutes of all Board meetings and decisions shall be written in the Somali language or English.

8) In keeping with the purposes and objectives of PHD, the Board shall establish policy for the guidance of the Executive Director, who shall be responsible for the day to day operation of PHD. The Board shall monitor compliance with its policies.

9) The Board shall elect the Executive Director for two year periods, and shall have authority to remove him or her at any time for cause.

10) The Auditor shall perform a complete audit of PHD account at the end of each fiscal year, or more often, as directed the Auditor shall be a certified accountant, and shall not be an employee or consultant of PHD.

11) Upon the recommendation of the Auditor, the Board shall establish an operating budget for each fiscal year, and shall approve completed fiscal year accounts.

PHD — BOARD OF DIRECTORS MEMBERSHIP

The Auditor shall be a certified accountant who has performed major audits, and who is not an employee or consultant of PHD. Eligibility rules for other members are as follows.

1) Each member shall be a well respected member of the public.

2) Citizens of any country are eligible for membership, however a majority shall be citizens of the Somali Democratic Republic.

3) All members shall be recognized for their active support of democracy liberalism, equality of sex, justice and charity.

4) All members shall recognize the need for development and shall be prepared to give freely of their time when needed.

5) All members must have previous experience in public activities and public relations.

PHD — MANAGEMENT

PHD shall have an Executive Director who is responsible

to the Board Directors for day to day management of the organization. He or she shall be responsible for cost effective operation of PHD and shall of its projects, continuously endeavoring to fulfil the objectives and purposes of PHD, under the policy guidance of the Board of Directors.

Policies which shall be established by the Board and implemented by the Board and implemented by the Executive Director include the following:-

- General management.
- Fund raising and contributions.
- Project implementation.
- Project selection.
- Contract award and administration.
- Budget, fiscal and accounting.
- Personnel policies for recruitment, compensation, fringe benefits, and advancement.

- 1) Frosion control.
- 2) Water resource development.
- 3) Improvement and maintenance of roads.
- 4) Municipal services.
- 5) Drainage protection.
- 6) Training.
- 7) Income generation.
- 8) Alternative energy development.
- 9) Private enterprise development.
- 10) Agricultural development (incl livestock).
- 11) Marketing and trade development.

PHD — ACCOUNTING

1) All instructions to the accountant or cashier must be in writing.

2) Loaning of PHD funds to any individual or organization is not allowed.

3) An approved purchase order is required before payment.

4) Complete inventories of all non-expendable properly must be maintained.

5) Separate accounting and separate bank accounts must be maintained for each different funding source.

6) A petty cash fund shall be established and maintained for each funding source, if required. Cash can be replenished only by checks written on the appropriate bank account.

7) Monthly reconciliations between each account and its bank statement must be performed by the Executive Director or designated person, other than the regular accountant.

8) A budget shall be established for each fiscal year of operations, and approved by the Board of Directors.

9) Expenditures for each budget line and project activity are to be accumulated and reported quarterly.

10) A system of cash advances to contracts shall be established and maintained. No contractor will be advanced more than needed for two weeks operations. Advances will be suspended whenever receipts supporting the advances are not submitted within a two week period.
