

SHARCIGA HAYADA

I. MAGACA:

Hayada magaceeda waxaa la yiraahdaa Istaageer Agri-cultural Development, waxaana loo aqoon sanayaa «Istaa-geer».

II. TARJUMAD/MICNAYN:

1. Istaageer: Xaraakaan, markii Af-Soomaaliga loo eego, tastuurkaan dhexdiisa micnaha uu ku leeyahay waxaa weeye, isuurin, iscwimid iyo isu adeegid.

2. Marka sidii ay ku haboon tahay, tastuurkaan dhexdii-sa labka iyo dhediga isku si ayaa loo qaadanayaa, wadar iyo waaxidna waa isku jiraan.

III. UJEEDADA HAYADA LOO ASAASAY:

Hayadaan Istaageer waxaa loo asaasay in ay gacan ka geysato baalunda veeraleyaa yaryar si ay u siyaadisnaan wax soo saarkooda dhanka cuntada isku filaan shanooqana kor ugu qaaqaaan.

IV. HAYADA XARUNTEEDA:

Hayada xarunteeda waxay ku oolaysaa Xamar, hase ahaatee, haddii loo baahdo ama ay balaarato hayada shaqadeedu, waxaa laamo iaga furi karaa meelihii ku haboon oo wadanka gudhiisaa, khaas ahaan nawaaxiga beeraha.

V. UJEEDOOYINKA HAWLEED:

Sugitaanka isku filaanta dhanka cuntada iyo wax soo saarku, waa waajibka ugu horeeya oo ummad kastaa saaran, arrintaas oo ah baahi Soomaaliya hadda ka taagan aadna uga fog dhamaystir. Hayadaan Istaageer waxay si weyn isugu taxalujinaysaa iyadoo la kaashanaysa hayadaha kale oo samafalkaa (kuwa gudaha iyo kuwa dibedaba) inay gacan ka geysato horumarinta beeraha. Hayadu waxay si khaas ah isugu taxalujinaysaa horumarinta beeraleyda yaryar, tacalliinta beeraha ee beeraleyda yar yar iyo horumarinta mashruucyada yar yar.

Istaageer waxaa ujeedooyinkeeda laf dhabar u ah inay door weyn ka gasho wax ka qabashada cunta yarida taasoo ku dhisan qorsha dheer.

Istaageer waxay ahaanaysaa hayad aan siyaasi iyo faa'iido doon midna ahayn (NGO), waxay fulinaysaa ujeedoo-

yinka halkaan ku qeexan.

1. Inay ka caawinto beeraleyda yar yar dhanka sharciga ee helitaanka dhulka beeraha.

2. Inay siiso hadba tabartu say tahay, beeraleyda yar yar taageero dhanka farsamada iyo talada.

3. Inay ka caawinto dhanka waraabka beeraha (kanaal lo iwm.)

4. Inay ka caawinto dhanka qodida ceelasha (ceelasha gacanta).

5. Soo saarida iyo gacan ka siinta bacrinta beeraha (fertilizers).

6. Inay gacan ka siyyaan dhanka dabargoynta cayayaanka beeraha.

7. Ka taageerida qalabka yar yar ee beeraha iyo kuwa waaweynba.

8. Gacan ka siinta dhanka tacaliinta beeraha iyo taciliinta kalaba.

9. Inay samayso meelaha lagu barbaariyo geedaha, si beeraleydu u hesho geedaha khudaartu ka baxdo iyo kuwa hooska, iyo in la sameeyo barnaamij geed abuurka (forestry projects).

10. Abuurista mashruucyo yar yar oo bulshada u soo jiida dakhli dhaqaale.

11. Dhaqashada iyo xanaanada xoolaha, iyo soo saarida farmaaiada iyo subaga.

12. Caafimaadka (dawooyinka, qalabka isbitaalada iyo shaybaarka).

13. Ka qayb gelida arrimaha masiibooinka dhanka cunta varida iyo daadadka iyo fatahaada wabivaasha.

14. Soo saarida buriiko doraxeedka (solar stoves) iyo dib u habavnta aluminamka (aluminum recycling).

15. Ivo gacan ka gevsashada ivo samafalka wixii kale oo havad samafal ahi samavn karto sida dharka ivo huura kale ee taakulevnta dadka tahaalaysan (Anything of relief and development materials for the community).

CONSTITUTION

I. NAME:

The organization will be known as Istaageer Agricultural Development, hereinafter referred to as Istaageer.

II. INTERPRETATION:

1. Istaageer: This word, in Somali language, means supporting, helping or serving each other.
2. Wherever appropriate, throughout this constitution, the masculine shall be considered to include the feminine and the singular the plural.

III. STATEMENT OF PURPOSE:

Istaageer Agricultural Development is established to improve the quality of life in rural Somalia by meeting basic needs and helping increase self-reliance in food production.

IV. MAIN OFFICE:

The head office of Istaageer will be situated in Mogadishu, Somalia. In case of need and/or expansion of the services of Istaageer, branch offices could be opened at other appropriate centers in the country.

V. SERVICE OBJECTIVES:

The food security of the nation is much more important than any other security need, and Somalia is faced with the task of feeding its people. This need is far from being met and, Istaageer will strive, with the help of other national and international NGO's, to further agricultural development. The organization will especially engage in agricultural development and education of small-scale farmers and small income-generating community development on humanitarian basis. Istaageer's central objective shall be to assume a major role in solving food shortages among communities on long range basis.

Istaageer shall strictly remain and operate as a non-profit indigenous NGO and non-political organization. In furtherance of the objectives, but not further or otherwise, Istaageer shall exercise the implementation and/or participation of the following principal services.

1. To assist farmers in the legal aspects of land procurement;
2. To provide technical assistance to farmers (small-scale farmers);
3. To assist in irrigation needs (canals etc.);
4. To help provide water (hand-dug or drilling of water wells for farmers);
5. Production (from animal bones) and procurement of fertilizers;
6. Provision of seeds;
7. Pests control (and procurement of pesticides);
8. Support on small scale farm implements;
9. Agricultural education (and other types of training);
10. Nurseries (for planting fruit trees) and forestry;
11. Creation of small income-generating projects for communities;
12. Animal husbandry and production of cheese, butter and ghee;
13. Aluminium recycling and production of solar stoves;
14. Vegetables drying and fruits preservation;
15. Health (medicines, hospital and laboratory instruments procurement);
16. Emergency/disaster participation (floods, food shortages, clothings);
17. And any other charitable projects withing the reference of the aims and objectives of the organization as deemed appropriate by the management.

VI. OTHER OPJECTIVES/POLICIES:

1. To collaborate and co-operate as considered appropriate with national and international non-governmental and governmental organizational and international non-governmental and governmental organizations.
2. To merge or affiliate with, aquire and/or take over any charitable organization and all or any assets in furtheance of Istaageer's objectives.
3. To carry into effect the objectives of Istaageer, by making proper arrangements and for this purpose provide in whole or part remunerations of all employees and other ex-

penditures to the management of the organization.

4. To raise funds primarily from running organizations and individual donors as shall be considered appropriate, legal and expedient without undertaking any transaction where profit-seeking is involved; and reserve the right to accept or disclaim any donation or assistance without prejudice to the generality of Istaageer.

5. To open and maintain a banking account or accounts in the name of Istaageer at any bank and at any time as may be deemed necessary; and to do all such other legal permissible activities in furtherance of the organization's objectives.

VII. THE EXECUTIVE BOARD:

The Executive Board of Istaageer shall consist of the following officers.

1. Chairman
2. Vice-chairman
3. Executive Director
4. Treasurer
5. Secretary

Some of the Executive Board offices may not be utilized at times if so deemed appropriate by the management. The responsibilities and the positions of the Executive Board are reviewable at any time considered appropriate by the majority of the Executive Board and the Founders.

RESPONSIBILITIES OF THE EXECUTIVE BOARD

1. The Chairman

The chairman is to function as one of the principal leaders of the organization and will be responsible for the presiding over all meetings of the executive board, unless otherwise prevented by a force majeure or other reasonable cause. The Vice-chairman will closely work with the chairman and perform his duties when he is absent.

2. The Executive Director

The responsibility of the Executive Director is to function as one of the principal leaders of the organization and will be responsible for the execution of the organization's managerial operations.

3. The Treasurer/accountant

Based on the decisions and directions of the manage-

ment, the treasurer will perform the duties of receiving and disbursing of organization funds and should issue receipts for moneys received and maintain vouchers for disbursements. As a whole, the treasurer will be responsible for the organization in the matters of financial record keeping, preparation of financial statements and preservation of accounts and books for auditing and/or inspection.

With the prior consultation and approval of the management, the treasurer could delegate part of his duties to another employee under his supervision and will be held responsible for the proper appropriation. All funds disbursed on behalf of the organization will be authorized by the Management Board (esp. the executive director). The executive management will be responsible for all the managerial duties of the organization and may give leadership and direction to the employees in a manner commensurate with the aims and objectives of the organization.

4. THE SECRETARY

Under the directions of the management, the secretary, besides being responsible for the performance of all the normal secretariate duties of the organization, will carry out all the duties pertinent to the correspondence, preparations of schedules to convene meetings and keeping minutes and preservation of records of organization proceedings.

VIII. EXECUTIVE BOARD MEETINGS

The Executive Board will hold meetings at least once a month. The Chairman, or in his absence the vice-chairman or in the default of both these, the Executive director will preside all meetings of the organization. The quorum for the executive board meetings will not be less than fifty percent. Any member failing to attend three consecutive meetings of the without some genuine cause, should receive a written notice for justification from the chairman. However, at the event that such a member fails to come up with justifiable reason or continues to be absent from meetings, the rest of the management will take action and he shall cease to be a member of the Board.

At his discretion, the chairman shall decide the number of persons allowed to speak against a motion or in favor of it.

and resolutions will be made by a simple vote of raising hands.

IX. THE ADVISORY BOARD

The Advisory Board of Istaageer shall be composed of two (2) agriculturists with adequate experience and an economist. The advisory board shall be charged with responsibilities for the organization and their number shall be not less than three (3) persons at any one time.

X. SUPPORTERS/CONTRIBUTORS

Any organization or person, regardless of country, nationality, race, color and faith shall be eligible for becoming a supporter, donor or a contributor of Istaageer, such supportship being subject to the consent of the Executive Board. The principal function of a supporter, contributor or a donor, is to assert his support to the organization both inward and action, but cannot claim any special rights or privileges. The executive board of the organization reserves the sole power and responsibility to sanction or reject any offer or application of supportership.

Supporters shall be expected to pay an amount of subscription individually as may be decided from time to time by the management and the founders of the organization. Any supporter desiring to resign from the organization's patronage, shall have the right and privilege to do so; however, such resignation will not take effect until the Founders have given due consideration to the matter. The executive board with the knowledge of the Founders shall have the authority to discontinue and/or exclude any supporter from his supportship for a specified time period on such grounds that he acts in a manner inconsistent or detrimental to the policy and the interest of the organization.

An organization or person who gives up or expelled from the status of being a supporter or contributor, will not be entitled to any reimbursement of contributions or subscriptions or any part thereof or any value contributed by him at any time.

The Founders of Istaageer shall be vested with the responsibility for all the properties funds and investments acquired in the name of the organization. In order to promote and achieve in practice the set activity objectives Istaageer shall seek and endeavor to facilitate collaboration and conne-

ration with other indigenous and international NGOs, in particular, the organization shall work together with funding organizations as equal partners in designing programs and development projects.

Istaageer shall cooperate with any organization and will make agreements with them to obtain any aid in the form of materials, funds, services or organizational objectives.

XI. THE FOUNDERS

The Founders, who function both in the Advisory Board and the Executive Board, shall be consulted in all decisions as the final authority in the decision making of the organization's affairs. They may overrule any decision if they have reason to believe that it is against the interests and the objectives of the organization. The Founders shall remain as the supervisors of the organization for life (their names appear at the end of this constitution).

XII. AUDITING

An auditor who is not an office holder of the organization, shall be appointed for every year to audit all the records, accounts and the books of the organization.

The treasurer or the accountant of the organization will produce all the necessary documents to be audited to the auditor and the auditor shall be expected to either certify the records as correct and vouched in accordance with proper accounting principles and organizational policies or state his opinion and findings to the contrary.

XIII. AMENDMENTS

The constitution of the organization can be amended, if the amendment so proposed is approved by the Founders with the consultation of the management.

XIV. DISSOLUTION

If the Founders, with prior consultation of the Executive Board and the Avdisory Board, decides unanimously that the object of this constitution cannot and will not continue to be carried out or at any ime determines that it is advisable to discontinue the organization, the assets remaining af-

ter all debts and liabilities are satisfied, could be given to a charitable organization, or shall be supervised by the Founders in the best way appropriate.

XV. Istaageer Agricultural Development shall be entitled to exemptions from import and customs duties on materials and equipment specifically imported for the implementation of the organizations programmes (REF, Law No. 21 of 26.8.63 article 58).
