RITENUTA Opportuna la necessità di concedere esenzione parziale sulla nafta in relazione alla siccità per salvaguardare i bananicoli dei comprensori Basso - Shebeele.

DECRETA:

Art. 1

Con decorrenza dal 1° Gennaio 1974 i proprietari dei pozzi Aziende Agricole — Basso-Shebeele beneficeranno esenzione parziale sulla nafta nella misura di 0,43.

Art. 3
