THE PRESIDENT

OF THE SUPREME REVOLUTIONARY COUNCIL

The President of the Supreme Revolutionary Council Taking Note of the approval of the Supreme Revolutionary Council and the Council of Secretaries;

HEREBY PROMULGATES

The following amendment to the Laws Governing Livestock Development Agency.

CHAPTER I.

Article 1

1. Wherever used in this Law, unless the context otherwise requires, the following terms shall have the following meanings:

- a) «AGENCY» means the Livestock Development Agency (LDA).
- b) «SECRETARY» means the Secretary of State for Foreign Trade.
- c) «LIVESTOCK» means cattle, camels, sheep, goats and poultry.
- d) «MINISTRY» means the Ministry of Foreign Trade under which the Agency comes.
- e) «MEAT» means fresh, chilled, frozen or canned meat.

2. The Agency shall remain an autonomous body with juridical personality as provided by Law No. 16 of 1st April, 1970. In addition the Agency shall be subject to the provisions of the following Laws:

- a) Law No. 36 of 22nd April 1972 on Personnel of Autonomous Agencies;
- b) Presidential decree No. 74 of 22nd April 1972 on Staff Regulations of Autonomous Agencies hereinafter called «Staff Regulations».
- c) Law No. 58 of 31st July 1972 on Finance of Public Enterprises and Agencies.

Article 2

Organisation

1. The Agency shall function, under the supervision of the Ministry of Foreign Trade, hereinafter referred to as the «Ministry».

2. The Agency shall have its head Office in Mogadishu but it may have offices in other regions and districts.

Article 3

1. The Agency shall have and exercise such powers to control and regulate the purchase, possession, movement, sale, import and export of all livestock, poultry, meat, eggs and by-products, as may be necessary in order to carry out its objectives, and purposes.

The Agency shall inter alie have power to:

- a) Construct, own and operate holding grounds, grazing ranches, irrigated farms, feedlots, marketing places, stock routes, staging points and marshalling yards.

- b) Operate and direct livestock and poultry markets.
- c) Establish and operate stock routes with watering facilities and reserved grazing areas to enable livestock to be moved from primary markets to processing facilities or exportation points, in the best possible condition.
- d) Formulate, the pricing policy of livestock, meat, eggs and by-products when considered necessary from the standpoint of the national economy, and to seek Government concurrence on said pricing policy.
- e) Draw up and establish reliable weighing procedure and grade specifications for livestock, poultry, meat, eggs and by-products and enforce the same.
- f) Fix, impose and collect fees on all livestock using the facilities provided by the Agency for meat, poultry and by-products exported from or processed in Somalia.
- g) Take over and carry out the supply of meat, poultry, eggs and by-products to the urban centres and also the supply of livestock to the livestock processing plants.
- h) Cooperate, with the Ministry of Livestock, Forestry and Range for the effective control and eradication of livestock diseases.
- i) Import and provide Veterinary drugs and vaccines, agricultural equipment and machinery, feeds, pumps and other equipment required for irrigation as well as any other items as may be required for LDA's overall operation.
- j) Buy and sell livestock and livestock products both domestically and abroad.
- k) Establish and operate quarantine stations for livestock in order to ensure international standards of health control in respect of livestock for export.
- l) Cooperate with the authorities concerned in the implementation of proper measures to be taken for utilization of grazing areas by stock-owners.
- m) Study, and assist in solving any problem, pertaining to the development of the livestock and related and associated industries as and when LDA's assistance is called for by the authorities concerned with livestock development.
- n) Take on, whenever appropriate, the exclusive export of livestock, livestock products and related products. The right to exclusive export shall be established by decree of the President of the Supreme Revolutionary Council on the proposal of the Secretaries of State concerned with livestock development.

- o) Participate with international organizations, business concerns, or private persons for carrying out projects within the competence of the Agency with the prior approval of the Secretary.
2. The objective of the Agency specified in article 4 paragraph 9 of Law No. 34 of 26 June 1970 is hereby repealed.
3. The Agency shall have all other powers as shall be deemed necessary for the proper achievement of its functions.

CHAPTER II.

Article 4

Organs of the Agency

The Agency shall have the following organs:

- a) The General Manager.
- b) Departments which the Agency shall establish when the Regulations of the Establishment of the Agency are enacted.

Article 5

Staff of the Agency

1. The General Manager and the Heads of Department of the Agency shall be appointed by the Decree of the President of the Supreme Revolutionary Council on the proposal of the Secretary.

2. The Agency may appoint other staff whenever it needs, according to Law No. 36 of 22nd April, 1972 and the Decree of PSRC No. 74 of 22nd April, 1972.

Article 6

Functions of the General Manager

The responsibility of the General Manager of the Agency is to administer the Agency according to this Law in its best interest.

CHAPTER III.

Article 7

Terms and conditions of service

The terms and conditions of service including the emoluments of the General Manager, Directors and other staff of the Agency shall be subject to provision of the Law on Autonomous Agencies and the Staff Regulations as set out in Article 1, (b) and (c) of the said Law.

Article 8

Authorized loans of the Agency

The Agency may, for the purposes of its activity, obtain loans from the Government and financial institutions within the Somali Democratic Republic and abroad with approval of the Secretary of State for Foreign Trade and the Secretary of State for Finance.

Article 9

Budget and Annual Accounts

1. The General Manager shall, not later than 30th September each year cause to be prepared the Annual Budget Statement showing the estimated receipts and expenditure of the Agency. The Annual Budget Statement shall be submitted to the Ministries of Foreign Trade and Finance.

2. On or before 31st March each year, the General Manager shall cause to prepare the Annual Accounts and profit and loans statement of the Agency which shall also be submitted to the Ministries of Foreign Trade and Finance.

Article 10

Financial year

The financial year of the Agency shall begin from 1st January and end on 31st December each year.

Article 11

Maintenance of Accounts

The Agency shall, at all times, keep proper accounts of its Funds and other money transactions, which shall be maintained in accordance with Law No. 56 of 31st July, 1972 and other laws of the Somali Democratic Republic.

Article 12

Audit of Accounts

The Accounts of the Agency shall be audited by a separate unit established in the Office of the Magistrate of Accounts for the purpose of auditing Autonomous Agencies.

Article 13
Regulations

The President of the Supreme Revolutionary Council may, by Decree, on the proposal of the Secretary, issue Regulations for the proper implementation of this Law.

Article 14
By Laws

The Secretary, in consultation with the General Manager may form internal Rules for the proper organization and functioning of the Agency.

Article 15
Repeal

Law No. 14 of 11th November 1973 and any other Law or provision contrary to or inconsistent with this Law is hereby repealed.

Article 16
Entry into Force

This Law shall come into force on the day it is signed by the President of the Supreme Revolutionary Council and shall be published in the Bulletin of the State.
