Ujeedada Wakaaladdu waxay tahay:

1. Inay maamusho, ilaalso ama isku hagaajiso wax allaale wixii ku saabsan Hargaha iyo Saamaha ama ganaci ku lug leh arrintaas oo Jamhuriyadda Dimoqraadiga ah ee Somaliya. Micnahaasi wuxuu saameynayaa soo saaridda, hagaajinta, isticmaalka iyo mushtarka alaabtaan; gaar ahaanna Wakqladda xaq gooniya ayuu siinayaa inay iib gayso ama soo iibsato alaaboo yinkaas oo dhan, wixii laga sameeyo iyo wixii kale ee sancadaasi u baahan tahay.

2. Inay kale taliyaan una gudbiyaan wixii talooyin ah waaxda xanaanada Xoolaha iyo Xoolaleydaba cudurada dhaawaca u geysta hargaha iyo cudurada hadba jira, dhulkay jiraan iyo wixii kale ee dhaawac u gaysan kara hargaha iyo Saamaha intaan neefka la qalin, kalana taliyaan sidii loo cidhib tiri lahaa cuduradaa iyo dhibaatooyinka kaleba.

3. Inay gargaaraan lana shaqeeyaan Dawladaha Hoose, marka loo baahdانا taageero lacageed siiyaan, si ay u sameeyaan meelo hagaagsan oo xoolalahalagu qalo iyo wixii laageero ah ee taa taageeri lahaa; khaas ahaanna sidii ay u sameyn lahaayeen wax-yaalihii hagaajin lahaa soo saarista Hargaha iyo Saamaha (Production and preparation).

4. Inay sameeyaan, maamulaanna (Extension Service) taabba gal ah oo ay tahay inuu qabto waajibaatka soo socda:

- i) Shaqa debedeed (field Work) uu ku hagaajinaayo iskuna dubbaridayo hawlaha ay ku kacayaan xoolalayda iyo dadka ganacsatada ku shaqda lihi Hargaha iyo Saamaha;

- ii) Inay ku kacaan wixii baadhis ah ee teknikal ah (technical research) kuna camal falaan wixii taa ka dhasha;
- iii) Inay fuliyaan wixii qaynuun gaar ah, ahaadaanna dadka ka taliya laysamada dhiibidooda, guud ahaanna ay hirgeliyaan siyaasadda dawladda ee ku saabsan arrimadaasi;
- iv) Inay ku kacaan alaabtaa ayada ah suuq u doonaan una helaan sicirada ugu habboon, waxa ka soo baxa wershedaha Qaranka Somaliyed ee ku saabsan Hargaha, Saamaha, maaska iyo wixii maaska laga sameeyo.
- v) Inay gacan siiaan tababarada, meelaha iyo wixii lagu tababari lahaa dadk Somaliyed ee looga baahan yahan horeumarinta ujeedada Wakaaladda loo leeyahay.
- vi) Caam ahaan in Wakaaladdu dhiiri geliso, taageerona u gey-sato dadka xoolaleyda ah ama hawshan ku lugta leh.

Institution Autonomous Agency for the Hides and Skins.

THE PRESIDENT
OF THE SUPREME REVOLUTIONARY COUNCIL

TAKING NOTE of the approval of the Supreme Revolutionary Council and the Council of Secretaries;

HEREBY PROMULGATES

the following Law:

Chapter One

Article 1

General Provisions

1. The Hides and Skins Agency is hereby established and is hereinafter referred to as « HASA ».

2. It shall be an Autonomous Agency with juridical entity and shall be governed by the provisions of this Law and shall also be subject to the provisions of:

- a) Law governing Autonomous Agencies and Audit of Industrial and Commercial and Credit Institutions with State participation (Law No. 16 of 1st April, 1970) as amended up to date.
- b) Law on personnel of Autonomous Agencies (Law No. 36 of 22-4-1972).
- c) Staff Regulations of Autonomous Agencies (D. P. SRC 74 of 22-4-1972 hereinafter referred to as the «Staff Regulations).

3. The Agency shall be classified as being in Category «B» within the meaning and provisions of Law No. 22-4-1972 and the Decree of the President of the Supreme Revolutionary Council No. 74 of 22-4-1972.

Article 2

Supervisions of the Agency

1. The Agency shall be under the supervision of the Secretary of State for Foreign Trade.

2. The Secretary of State for Foreign Trade may give HASA such directives as he may consider necessary from time to time in order to ensure that its acts in accordance with the best interest of the State.

Article 3

Head Office and branches

The Agency shall have its Head Office in Mogadiscio and open branches, representative office and Agents in other places within the Republic and abroad.

Article 4

Objectives

The objectives of the Agency shall be:

1. To conduct the activities pertaining to the regulations and to control all commercial aspects of the Hides and Skins and partly or wholly tanned leather and allied trade within the Somali Democratic Republic: this definition shall include all activities associated with the production, preparation, utilisation and commercialisation of these commodities and materials and shall specifically include the exclusive right to import or export these commodities and materials and their by-products and associated chemicals or other agents required for their trade.

2. To advise and issue the required directives to the Veterinary animal Husbandry Services, as well as the stock-owners, concerning the types, incidence and prevalence of skin damaging diseases and other causes, of pre-slaughter damage inflicted to the Hides and skins and suggest ways and means of combating such defects.

3. To liaise and work with Local Government Authorities, extending to them technical and financial assistance where necessary, to provide amenities and proper facilities to deal with the slaughter of livestock for meat and particularly to create the proper facilities for the improved handing, production and preparation of Hides and Skins.

4. To establish and operate an efficient extension service to:

- i) undertake practical field work and to direct or regulate the activities for the production and of the trades concerned;
- ii) carry out technical research work and apply as appropriate;
- iii) enforce relevant legislation and advise licensing authority and generally to carry out Government Policies in the relevant spheres of activity;
- iv) carry out marketing research and secure the most beneficial market for the products of the National Hides and Skins and leather industries;
- v) assist with the provision of training, facilities and amenities for development of the skills of the national manpower which will be necessary to carry out the stated objectives of this Agency;
- vi) provide inducement and practical assistance to national producers participating in the relevant spheres of activity;

5. To encourage the rapid development of a network of processing industries with the specific aim of processing, either partly or totally, all available hides and skins and either exporting them as semi-finished or finished products, or making them available to national leather utilisation industries requiring them.

6. Generally, to take all possible steps to ensure that the relevant trades shall be developed and exploited for the overall national benefit to the maximum extend.

Article 5

HASA shall have the authority to assume such powers considered for the attainment of its stated objectives.

Chapter Two

ORGANISATION

Section One — ORGANS OF HASA

Article 6

The following shall be the organs of HASA:

1. General Manager
2. Directors of Departments
3. Management Committee.

Article 7

Appointments

The General Manager and the directors of departments of HASA shall be appointed by a Decree of the President of the Supreme Revolutionary Council on the proposal of the Secretary of State for Foreign Trade.

Section Two — FUNCTIONS

Article 8

General Manager

The General Manager of the Agency shall:

- a) be responsible for the implementation of Laws, regulations and policy programmes of the Agency;
- b) recommend plans which will facilitate the growth of the Agency in a manner consonant with its objectives;

- c) review and analyse the technical and commercial performance of the Agency with a view to improve the efficiency and productivity of the staff;
- d) maintain effective coordination within the Agency and with other organs of the Government;

Section Three — STAFF

Article 9

HASA may appoint the staff required by it in accordance with Law No. 36 of 22-4-1972 and staff regulations D P. SRC 74 22-4-1972.

Article 10

Terms and Conditions of Service

The terms and conditions of service including the emoluments of the General Manager, the Directors of Departments and other staff shall be governed by the Law on personnel of Autonomous Agencies and staff regulations.

Chapter Three

Article 11

Capital

The Capital of the Agency shall consist of:

- a) a sum of So. Shs. 100.000 provided by the State;
- b) any funds deriving from commercial activities of the Agency;
- c) any levies or fees accrued as a result of the application of any legislation which may be adopted by the Government on the

service rendered by HASA.

Article 12

Authorised Loans

The Agency may, for purposes of its activity, obtain loans from financial institutions within the Somali Democratic Republic and abroad with the approval of the Secretary for foreign trade.

Article 13

Financial Year

The financial year of the Agency shall be from 1st January, to 31st December each year.

Article 14

Budget and Annual Accounts

1. The General Manager shall, not later than 31st December each year cause to be prepared a statement to be called the Annual Budget statement for the next financial year showing the estimated receipts and expenditure of the Agency. The Agency's annual Budget Statement can be submitted to the Ministries of Trade and Finance.
2. On or before 31st March of each year, the General Manager shall cause to prepare the annual accounts and Profit and Loss Statement of the Agency and shall submit the same the Ministries of Foreign Trade and Finance. The Secretary shall, in consultation with the Secretary of State for Finance, be competent to approve the said annual accounts.

Article 15

Maintenance of Accounts

The Agency shall, at all times, keep proper accounts of its funds and transactions, which shall be maintained in the manner prescribed by any law and regulations issued by the State for the purpose and by an regulations issued hereunder.

Article 16

The Accounts of the Agency shall be audited by a separate unit established in the Office of the Magistrate of Accounts for the purpose of auditing autonomous Agencies.

Article 17

Regulations

The President of the Supreme Revolutionary Council may, by decree, on the proposal of the Secretary, issue regulations for the proper implementation of this Law.

Article 18

Internal Rules

Subject to the provisions of the laws set out in paragraph 2 of Article 1 above, the General Manager may, with the approval of the Secretary, issue Internal Rules governing the Organisation, establishment and other related matters of the Agency.

Article 19

Repeal

Any law or provisions contrary to, or inconsistent with, this law is hereby repealed.

Article 20

Coming into force

This law shall come into force immediately and shall be published in the Official Bulletin of the Somali Democratic Republic.
