#### **Qod. 1**

Waxaa la beddelay qdobka 2 ee amar-sharciga lamb. 28 ee 23 Disember 1951 oo la xiriira dhismaha Golaha Dhaqalaha ee Somaliya sida soo socota:

- h) — Laba khabir ee shaqalaha iyo badbaada bulshada.
